

- The program has been granted accreditation for further 3 years. Noida Institute of Engineering and 4. Technology(Pharmacy Institute), 19, Knowledge Park-II, Institutional Area, Greater Noida-201 306, Uttar Pradesh should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
- The accreditation status awarded to the program as indicated in the above table does not imply that 5. the accreditation has been granted to Noida Institute of Engineering and Technology(Pharmacy Institute), 19, Knowledge Park-II, Institutional Area, Greater Noida, Uttar Pradesh as a whole.
