2. An Expert Team conducted on-site evaluation of the program from 6th to 8th September, 2024. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The program has been granted accreditation for three years. **Noida Institute of Engineering and Technology(Pharmacy Institute), 19 Knowledge Park 2, Institutional Area, Greater Noida, Uttar Pradesh-201 306** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Noida Institute of Engineering and Technology(Pharmacy Institute), 19 Knowledge Park 2, Institutional Area, Greater Noida, Uttar Pradesh-201 306** as a whole.
